- Social Security card or ITIN document for each person on your tax return
- Photo ID for taxpayer (and spouse if applicable).
- W-2s from all jobs
- All 1099s, 1098s and any other tax forms
- Your household's health coverage information (Forms 1095-A, B or C)
- Child care provider information
- Landlord's name, address and phone number for CA Renter's Credit
- Savings and checking account and routing numbers for direct deposit
- Last year's tax return

*Volunteer Income Tax Assistance (VITA) volunteers provide FREE Income Tax Preparation Assistance to people who generally make \$60,000 or less, persons with disabilities, and limited English-speaking taxpayers.
